Guidance on COVID-19

All OID dancers and families may access the interior of the building for their classes. Masks and social distancing are absolutely still required indoors - most of our school-age dancers are only beginning their vaccinations or will not have a chance to be vaccinated until fall.

- PreSchool and Beginner family members may wait in the Lower Lobby. Primary students/caregivers may arrive/wait on the LEFT side of the Main Lobby (Elevator)
- Intermediate through Champ dancers/caregivers may arrive/wait on the RIGHT side of the Lobby (Fireplace).

If the area seems momentarily congested, please be aware and adjust appropriately. Thanks everyone for remaining vigilant in adhering to these protocols.

If a family member is sick or has been exposed to covid, please stay home and wait 10 days before returning to the facility.
